Volunteer Agreement and Release of Liability

My signature below indicates that I have read, understand and agree to the following:

1. I agree to be a volunteer for Dog World Rescue, Inc. I, _____, hereby agree that I am providing volunteer services to Dog World Rescue, Inc. by assisting in pet adoptions. This may also include assisting in adoptions of pets through Dog World Rescue, Inc. at local PetSmart stores. I understand that neither Dog World Rescue, Inc. nor PetSmart is responsible for any illness or injury caused by any animals that I come into contact with during my volunteer work. I hereby agree and release, indemnify and hold harmless Dog World Rescue, Inc., PetSmart, and associated Officers, Directors and Agents from any and all claims, damages and liability arising from or related to my activities as a Dog World Rescue volunteer; I further agree to release, hold harmless, and indemnify Dog World Rescue, its Officers, Directors and Agents from any and all claims, damages and liability arising from my riding as a passenger in any motor vehicle owned or leased by Dog World Rescue, Inc., its Officers, Directors and Agents and operated by any of them.
2. I understand and agree that the Dog World Rescue, Inc. website, internal files and records, including names and addresses of volunteers, donors, applicants, membership lists and similar data are the sole property of Dog World Rescue, Inc., and that unauthorized disclosure of such information, its appropriation, changes or alterations to it may constitute a criminal offense.
3. I understand and agree that the behavior of animals is unpredictable and that some animals are capable of inflicting serious personal injury or death, as well as significant property damage. I acknowledge that while Dog World Rescue, Inc. will take every reasonable precaution to minimize the potential of danger posed by the animals under its care, it is never possible to guarantee the temperament and/or behavior of any animal at all times and under all circumstances. I therefore agree that if I choose to walk, handle, foster or care for any Dog World Rescue, Inc. dog, I will do so at my own risk.
4. I understand and agree that if I fail to comply with the terms of this agreement or am otherwise unable to meet the Volunteer Program policies and requirements, I will be terminated from the Program.

I REPRESENT THAT I AM OVER EIGHTEEN YEARS OF AGE AND ACKNOWLEDGE THAT I HAVE READ THIS AGREEMENT CAREFULLY AND I FULLY UNDERSTAND ITS CONTENTS AND IMPLICATIONS. I AM AWARE THAT THIS IS A WAIVER AND RELEASE OF LIABILITY AND INDEMNITY AGREEMENT, AND THAT IT IS BINDING AND ENFORCEABLE BY LAW.
